Cllr Harris then asked for the councils assistance with the playing field at Sparnock Grove, Gloweth. Cllr Harris believes this is the responsibility of the developer but it attempting to find out if this is the case. The council agreed that in the meantime ,they will ask our contractor for a ROSPA inspection of the park and ask our contractor for a one off cut to improve the area until a permanent solution can be found. This assistance was proposed by Cllr Green, seconded by Cllr Robinson and 8 members were in favour and 1 abstention

# 2092/2023To discuss meeting at Shortlanesend Methodist Church instead of Shortlanesend Village Hall – Cllr Harry

Members were happy with this arrangement and asked Cllr Harry to make suitable contact

#### 2093/2023 To discuss dog bins for Idless woods and access to Idless – Cllr Robinson

Members discussed dog bins at idles and it was decided that we would make the necessary contacts with the forestry commission, Cornwall Council Highways department to decide on locations

Proposed by Cllr Green, Seconded by Cllr Robinson and the vote was unanimous

Members then discussed Idless not being included in the 20 mph roll out and decided that they wishes to lobby for its inclusion
